Finneytown Housing Block Watch

We are now into our third year. We have a loyal squad of Watchers numbering nine. Meet our newest Watcher, Mary Patton, on Fontainebleu. Mary is a typical watcher: She has no use for spreadsheets. So she tells me what she sees in plain old English. Then we chat back and forth by email to determine if she has a candidate for the WATCH List, or even more serious, the HOT list.

Three years ago we started FHBW using a detailed spreadsheet. It soon became clear that most Watchers were not comfortable with spreadsheets. So we went to Plan B: a .doc file. This .doc file has two sections: The **HOT LIST** and the **WATCH LIST**, each about a dozen listings. These listings help Township assistant administrator Chris Gilbert and the Property Maintenance Code folks zero in on the worst properties. So, exactly how does a property end up on one of these lists? It is a subjective judgment by a neighbor: "If I were in the market for a new home in Finneytown, would this property cause me to go elsewhere?"
